BYLAWS

CHATHAM ANIMAL RESCUE AND EDUCATION, INC.

Updated May 2019

ARTICLE I. NAME AND LEGAL BASIS

Section 1.

The name of this organization shall be Chatham Animal Rescue and Education, Inc., hereinafter referred to as CARE, a nonprofit organization incorporated under the laws of the State of North Carolina governing nonprofit educational and charitable corporations. (Chapter 55A North Carolina Nonprofit Corporation Act)

Section 2.

The organization is formed and operated on a nonprofit basis; no part of any net earnings and no dividends or other profits shall accrue to the benefit of any Board member or individual.

ARTICLE II. MISSION

The mission of CARE is to promote the health and safety of all cats and dogs in Chatham County. CARE promotes responsible pet ownership by educating the community, providing targeted spay/neuter programs, and fostering homeless cats and dogs until they are placed in loving, permanent homes. The purpose of CARE shall include all other purposes set out in the corporate charter and as allowed by law.

ARTICLE III. MEMBERSHIP

CARE shall not have any members.

ARTICLE IV. THE BOARD OF DIRECTORS

Section 1.

The Board of Directors shall consist of no fewer than eight, and no more than fifteen members, who shall serve without pay and shall, except as hereinafter provided, serve three-year terms. The Board of Directors shall be responsible for establishing the policies of CARE.

Section 2.

The members of the Board of Directors shall be elected at the annual meeting by the members of the Board and shall serve for a term of three years, may be reelected for one additional term for a maximum of two consecutive terms, and may serve again after a one year absence. One-third of the Board of Directors shall be elected annually. Members of the Board of Directors shall not receive any compensation for their services as Directors. No Director may serve as a paid employee of CARE; however, temporary paid contractors may serve as a Director if they are recused from decisions in any matter related to their paid activities.

Nominations and elections shall be as follows:

- A. The Governance Committee shall conduct nominations to the Board.
- B. Additional candidates for the Board of Directors and Officers may be nominated from the floor with the prior consent of the nominees at the January meeting.
- C. The election shall normally take place at the regularly scheduled Board meeting held in January, or as soon thereafter as possible. Election to the Board shall be by a majority of the Board members present at the meeting.
- D. Officers shall be elected by the Board of Directors at the January Board meeting by a majority of the Board members present.

Section 3.

There shall be a meeting of the Board of Directors with frequency to be not less than quarterly or as designated. A quorum for meetings of the Board of Directors shall be 51% of its members.

- A. Members may participate remotely in meetings by telephone, computer, or other device, as long as remote participants are able to hear all other participants and are able to be heard by all other participants. Remote participants shall be considered present at the meeting for the purpose of constituting a quorum.
- B. Special meetings of the Board of Directors may be called by the President or by any three members of the Board on 24 hours notice as provided in these Bylaws.
- C. Meetings of the Board shall be open to the public, except for those meetings or portions of meetings designated by the President or other Board members to be conducted in executive session. Any member of the public may attend public meetings of the Board of Directors. A presiding Board member may extend the privilege of the floor to any attendee.
- D. Notice under these Bylaws may be communicated in person, by telephone, by electronic means, or by mail or private carrier. Any Director may waive notice of any meeting by a written statement executed either before or after the meeting. Attendance and participation at a meeting without objection to notice shall also constitute a waiver of notice.

Section 4.

Each member of the Board of Directors shall have one vote. Motions shall be deemed approved when voted on by a simple majority (51% of the Board of Directors). Voting by proxy shall not be permitted.

Action required or permitted by these Bylaws to be taken at a meeting of Board members may also be taken outside of a regular meeting, and all members entitled to vote must vote on said action when the vote is taken outside of a regular meeting. The action shall be recorded and included in the minutes of the next scheduled meeting of the Board of Directors and shall have the same effect as though taken at a meeting of the Board.

Section 5.

The Board may remove any Board member for cause, including but not limited to, unsatisfactory attendance at Board meetings, or lack of significant contribution to Board

activities, by a vote of a majority of the total Board. Absence at three consecutive Board meetings may be a reason for a Board member's termination.

Section 6.

Should a Board member resign, be unable to complete his or her term of office, or otherwise cease to be a member of the Board, the Board of Directors, by a vote of a majority of all remaining Directors may fill any vacancy of the Board for the unexpired term of such position. Should the Board have less than fifteen members, the Directors may appoint new members by a majority vote for the vacant terms at any time during the year.

Section 7.

The Board of Directors shall establish the policies of CARE that shall be implemented by the Executive Director as provided herein.

ARTICLE V. OFFICERS

Section 1.

The Officers shall be a President, a Vice-President, a Secretary, and a Treasurer. Officers shall serve for one year, with a two-year consecutive maximum or until a successor is duly qualified or until they are removed from office as provided in Section 2 below. These Officers shall constitute the Executive Committee.

Section 2.

Officers are elected by a majority of the Board of Directors at the January meeting. The Board of Directors, by a two-thirds vote of all its members, may remove any Officer for cause or declare any office vacant and elect a successor to fill the unexpired term.

Section 3.

The duties of the Officers shall be as follows:

- A. The President shall convene and preside at all meetings of the Board of Directors, shall appoint the chair persons of all committees, and have the authority to delegate responsibilities to the Vice President or others as needed.
- B. The Vice President shall, in the absence or at the direction of the President, preside at all meetings of the Board, and shall act in the place of the President in the event of his or her absence.
- C. The Secretary shall record the minutes of all meetings of the Board of Directors, shall archive all minutes, bylaws, and policies of the organization, and shall preside at the Board member and Officer elections.
- D. The Treasurer shall oversee the custody of all funds, securities, and assets of the organization, shall ensure that the organization's Finance Policy is being followed, shall provide monthly and annual finance reports to the Board, and lead the Finance Committee.

ARTICLE VI. COMMITTEES

Section 1.

The role of committees in CARE shall be to help develop strategies, recommend policies, and oversee implementation of CARE's policies. Each Board member, other than Officers, shall serve on at least one committee as assigned by the President.

Section 2.

In addition to the Governance and Executive Committees described herein, there shall be six standing committees designated as follows: Dog Welfare, Cat Welfare, Education, Finance, Marketing, and Fundraising.

Section 3.

The President and the Executive Director shall be an ex officio, nonvoting member of all standing committees. The President may designate the Vice President to act in his or her stead as an ex officio member of the committees.

Section 4.

Each standing committee should have at least one Board member who shall be appointed by the President. The appointed Board members shall report back to the Board at monthly meetings in order to coordinate activities. The Chairperson of each standing committee shall appoint additional members.

Section 5.

All standing committees shall meet monthly when possible, submit a report from each meeting to the Board of Directors, present an annual report at the January Board meeting, and present special or interim reports as the President or Board of Directors may request.

Section 6.

The President has the power to establish and dissolve ad hoc committees and appoint chairpersons for those committees.

Section 7.

Governance Committee: The Governance Committee shall meet annually at a minimum, and be comprised of the Executive Committee, the chairs of both Welfare committees, and two non-Board members. This committee is responsible for Board recruitment, orientation, self-assessment, continuing education, mentoring, Board management, and evaluation of Board performance. The Governance Committee will meet to review the bylaws, policies, procedures, and job descriptions each January, or as soon thereafter as possible.

The Governance Committee will initiate the nominating process for new Board members each July, or as soon thereafter as possible. The nominating report will be submitted in writing

to the Secretary by the November Board meeting, with subsequent review at the November and/or December Board meetings.

Section 8.

Executive Committee: The four Officers serve as the members of the Executive Committee. Except for the power to amend the Articles of Incorporation and Bylaws, the Executive Committee shall have all the powers and authority of the Board of Directors in the intervals between meetings of the Board of Directors, and is subject to the direction and control of the full Board. Any action taken by the Executive Committee must be ratified at the next scheduled meeting of the Board of Directors. The Executive Committee provides oversight of the Executive Director, by establishing goals for the year, evaluating performance, and setting compensation. These activities shall be reported to the full Board.

Section 9.

Finance Committee: The Treasurer is the chair of the Finance Committee, which shall include the chair of both Welfare committees, the Executive Director, and a member of the bookkeeping staff as applicable. A member of the bookkeeping staff may also be included. The Finance Committee is responsible for developing and reviewing fiscal policies, procedures, and the annual budget. The Board must approve the budget and all expenditures must be within budget. Any major change in the budget must be approved by the Board or the Executive Committee. The fiscal year shall be the calendar year. Monthly and annual reports are required to be submitted to the Board showing income, expenditures, and pending income.

ARTICLE VII. EXECUTIVE DIRECTOR AND STAFF

Section 1. Executive Director

The Board of Directors shall hire an Executive Director who shall serve at the will of the Board. The Executive Director shall have overall supervision and day-to-day responsibility of the operations of the organization, including carrying out the organization's goals and upholding the organization's policies. The Executive Director, with approval by the Board, will hire or

discharge and determine the compensation of any staff members under the Executive Director's supervision.

The Executive Director will attend all Board meetings, submit detailed monthly written reports on the progress of the organization, answer questions from the Board members, and carry out the duties described in the job description. The Board can designate other duties as necessary. The Executive Director shall be an ad-hoc member of all committees.

The Executive Director may not be related by blood or marriage/domestic partnership to any member of the Board of Directors. The Executive Director may be hired at any meeting of the Board of Directors by a majority vote, and shall serve until removed by the Board of Directors upon an affirmative vote by a quorum. Such removal may be with or without cause. Nothing herein shall confer any compensation or other rights on any Executive Director, who shall remain an employee terminable at will, as provided in this section.

ARTICLE VIII. AMENDMENTS

These bylaws may be repealed, altered, or amended as follows: any proposed alteration to be brought before CARE shall be submitted in writing to the Board of Directors at least 5 days before the meeting. Such changes may be approved by a majority of the Board members. The Board shall designate when changes shall become effective. A current copy of the bylaws shall be available for review with the Secretary by members of the public.

ARTICLE IX. RECORDS OF THE CORPORATION

The books, records, and papers of CARE shall at all times, during reasonable business hours, be subject to inspection by any Director of the organization. The Articles of Incorporation and these Bylaws shall be available for inspection by any Director at the principal office of CARE.

ARTICLE X. INDEMNIFICATION

The organization shall have the authority to indemnify and hold harmless to the full extent permitted by law (Director Immunity Section 55A-8-60) and to purchase and maintain

liability insurance on behalf of any person who serves or has served as a Director, Officer, employee, or authorized agent of the chapter, or who serves or who has served at the request of the organization as a Director, Officer, employee or authorized agent of another corporation, partnership, joint venture, trust or other entity. To the fullest extent permitted by applicable law, no Officer or Director of the organization shall have any personal liability arising out of any action whether by or in the right of the organization or otherwise for monetary damages for breach of any duty as an Officer or Director. Any repeal of this section shall be prospective and shall not adversely affect any limitation herein on personal liability of any Officer or Director with respect to acts or omissions occurring prior to such repeal or modification.

ARTICLE XI. CONFLICT OF INTEREST

CARE shall have and strictly enforce a Conflict of Interest Policy. All CARE employees, managers, volunteers, and Board members shall be made aware of the Conflict of Interest policy.

ARTICLE XII. Dissolution (See NCGS 55A – Article 14 Dissolution)

Section 1.

An organization may be dissolved by an affirmative vote on a Plan of Dissolution by a majority of its Board of Directors then in office.

Section 2.

The plan of dissolution shall provide that all liabilities and obligations of the organization be paid and the remainder of the organization's assets be distributed to a non-profit organization that is exempt under 501(c) (3) and has a mission similar to that of CARE.

Section 3.

Articles of Dissolution shall be delivered to the North Carolina Secretary of State and are effective on the effective date of its articles of dissolution.
